Frank Lesneski

I Frank Lesneski, of the township of Huston in the county of Clearfield, and State of Pennsylvania, being of sound mind, memory, and understanding, do make and publish this my last will and testament hereby revoking and making void all former wills by me at any time heretofore made.

First, I direct that my body be decently interred in the Catholic cemetery in the city of DuBois, according to the rites and ceremonies of the Catholic Church, and that my funeral be conducted in a manner befitting my estate and condition in life.

Second, I direct all my just debts and funeral expenses to be fully paid and satisfied by my son James as soon as conveniently may be after my decease.

Third, I give and bequeath unto the living children of Martin, my son, at the time of my demise, one hundred dollars, same one hundred dollars to be paid by my son James (I not having any money of my own) as soon as conveniently after my demise.

Fourth, all the rest, residue and remainder of my estate remaining after the payment of my just debts and funeral expenses as aforesaid, whether real, personal or mixed, of which I shall die seized and possessed or to which I shall be entitled at my decease I give devise and bequeath to my beloved son James Lesneski for his own proper use and benefit forever.

Fifth, I do nominate and appoint my beloved son James Lesneski to be the executor of this my last will and testament.

In Testimony Whereof, I the said Frank Lesneski, have to this my last will and testament, put my hand and seal this fifteenth day of March A.D. one thousand and nine hundred and twenty-two.

Signed, sealed, published, and delivered by the above named Frank Lesneski, as and for his last will and testament, in the presence of us who have hereunto subscribed our names at his request as witnesses hereto, in the presence of said testator and of each other.

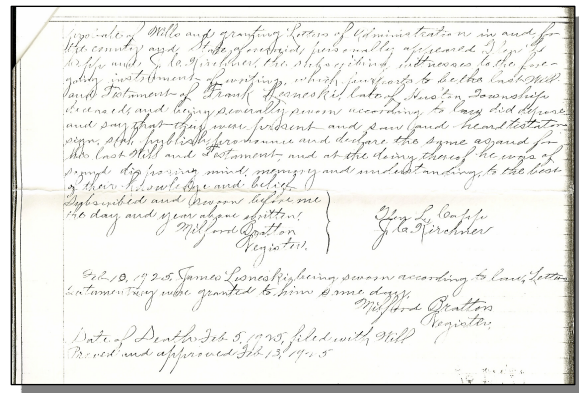
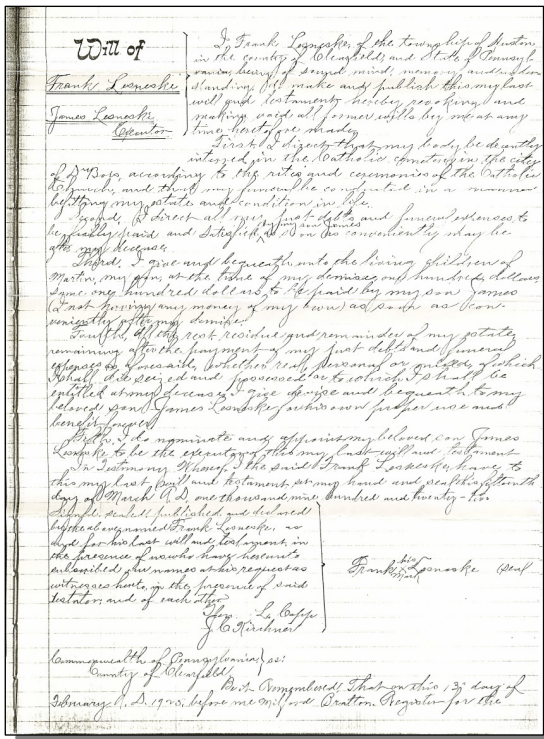
